Continuing Ithaca College degree students not registering for independent studies, internships, workshops, or performance studies should register online using Degree Navigator. Ithaca College students registering for independent studies, internships, workshops, or performance studies, as well as incoming and extramural students, must register in the summer sessions office, Towers Concourse.

Registering by Mail

Students registering by mail may pay by check, money order, or credit card. Make your check or money order payable to Ithaca College. Send the completed registration form and payment at least two weeks before your first class to Summer Sessions Office, Ithaca College, 120 Towers Concourse, Ithaca, NY 14850-7141. **Note:** Continuing Ithaca College degree students should register online for classroom courses using Degree Navigator.

Special Notes

- Continuing Ithaca College degree students should register online for their summer courses using Degree Navigator prior to making payment. These students will be billed by the bursar's office for summer charges. Payment is expected prior to the beginning of classes. (Charges will be reflected on the student information system.) Past-due balances must be paid in order to register.
