### **EXPECTATIONS FOR PARENTS:**

Observation: Parent/Guardians are invited, but not required, to attend and observe throughout the event's duration.

Lunch: A meal voucher will be provided for participating students during the designated time. Parents/Guardian are also able to eat in the dining hall, but at their expense.

COVID-19 Matters: If your Minor is experiencing any symptoms on the day of the event, please <u>do not</u> allow them to participate.

We will have each parent/guardian sign a covid waiver upon arrival for themselves and their prospect. If a prospect indicates or shows signs of illness, they will be removed form the event and our director will contact the emergency contact listed for pick up within 20 minutes.

### **SUPERVISION OF MINORS**

- Program Director, Co-Directors, Additional Instructors, and the IC Student Participants are all 'authorized adults' who are responsible for supervision of participating Minors
- Each authorized adult is responsible at all times for reporting suspected abuse or neglect involving any Minor participant, to the Program Director and to the Office of Public Safety
- Supervision standard is such that a Minor participant is protected from any unreasonable risk to their health or safety, including physical or sexual abuse or any public health hazard.
- Only Program Directors are responsible for maintaining disciplinary authority over participating Minors.
- At no time will any Program personnel (Program Director or any other employee, student-athlete, or representative) ever touch or physically restrain a participating Minor for disciplinary purposes.

#### PRIOR HEALTH CLEARANCE

Participants and their parents/legal guardians represented to the College that no medical condition restricts participation in this Program.

No other medical information has been provided and Program personnel <u>must not</u> administer any medications to minor participants by IC Program staff. See "Emergencies' below for all other health-related matters.

### TRANSPORTATION

Participants and their families are independently responsible for the Participants' transportation to and from the Program. Participants are released from the Program at the conclusion of the 3:00 pm concert performance, where supervision ends.

No transportation is to be provided to Participants by Program personnel.
